COUNTY DECLARATION OF EMERGENCY

WHEREAS, on July 25, 2022, the City of Adrian experienced the failure of a multi-story residential structure housing approximately 200 vulnerable individuals. As a result of this situation, the Chair of the Lenawee County Board of Commissioners in accordance with section 10 of Act 390, P.A. 1976 as amended, declared that a state of emergency exists therein and that response and recovery aspects of the emergency operations plan were activated within the City of Adrian and local resources are being utilized to the fullest possible extent.

WHEREAS, the results of this incident have left a number of County residents without shelter and other life necessities; and

WHEREAS, the crisis that led to the Chair's declaration continues to exist.

THEREFORE, BE IT RESOLVED that the Lenawee County Board of Commissioners, by this resolution, hereby ratifies the Chair's declaration of a State of Emergency and declares that the State of Emergency continues to exist.
